Re: Honoring Frank DeMartini – March 31, 1952 – September 11, 2001

Dear Representative Delgado;

I am writing today in loving memory of my dearest and best friend, Frank DeMartini who was killed in the North Tower of the World Trade Center on September 11, 2001. There are no words that can adequately express the deep sorrow I feel every day at the loss of such a wonderful and productive citizen of these United States of America.

Frank and I were students together at Pratt Institute School of Architecture. We graduated together in 1975 and sat for the Architects Exam together. We were partners in business and raised our families in a close knit and loving friendship.

I joined Architects and Engineers for 9/11 Truth in 2006 as one of the early signers to their petition requesting a new investigation of the events of September 11, 2001 in New York City. I have steadfastly maintained that the destruction of all three high-rise towers of the World Trade Center was not caused by office fires and, in the case of Towers One and Two the crash of jet liners into the sides of the buildings. These towers were destroyed in some manner of explosive devices. The evidence is clear. A collapse caused by plane crashes and random fires could not occur in the manner in which we saw the buildings explode, upward and outward with such force that all the concrete and glass was rendered to a fine powder which spread all across lower Manhattan in a layer several inches deep.

It is also obvious to me that Building 7, a 47 story steel structure that fell neatly into its own footprint in about 7 seconds at 5:20PM on September 11, 2001. The building was not hit by an airliner and was more than 300 feet away from Tower One, the closest of the two twin towers so it was not directly under the towers as were buildings 4,5, and 6 which were destroyed but did not collapse into their footprints.

I am including with this letter a DVD copy of the short film SEVEN. I urge you to view this film at your earliest convenient time. It is because of this film and our continuing efforts to uncover the mysteries of the destruction of these buildings that awful day that we, Architects and Engineers for 9/11 Truth and ten family members have submitted a "Request for Correction" to NIST regarding its 2008 final report on the destruction of Building 7. We are doing everything we can to insure that we follow the laws in our pursuit of the truth. This request is another example of that effort. Our request was filed under the Data Quality Act. To date, NIST is more than 3 months past due on answering our request.

I do urge you to review the Request at [AE911Truth.org/NIST](http://AE911Truth.org/NIST). I humbly ask that you use the power of your office to summon NIST to comply with their obligation to correct their report in light of this new exhaustive study into the destruction of Building 7. It is long past time for NIST to correct their erroneous report and for Congress to initiate a proper, detailed and unbiased investigation into the destruction of the entire World Trade Center Complex on September 11, 2001.

I submit this request to you in honor of my friend who was father to two charming children and husband to his lovely wife. Frank was an American Hero who gave his life so that others could live. He rescued many from certain death in the North Tower. Now you can do your part to honor his sacrifice by doing whatever you can to uncover the truth.

I would very much appreciate your letting me know what action you decide to take after reviewing these materials.
