Re: The Bobby McIlvaine World Trade Center Investigation Act

Dear Representatives Lynch, Capuano, and Clark:

It is with utmost urgency and concern for our country that we, on behalf of 90 architects and engineers from the Boston Metro Area who have signed the petition of Architects & Engineers for 9/11 Truth (see enclosed), call upon you to introduce the Bobby McIlvaine World Trade Center Investigation Act (see [AE911Truth.org/Justice](http://AE911Truth.org/Justice)).

It has become abundantly and painfully clear to us, as building and technical professionals, that the catastrophic destruction of the *three* World Trade Center Towers — Buildings 1, 2, and 7 — was never properly investigated by our federal government.

In September 2002, the U.S. Congress passed the National Construction Safety Team Act, which mandated the National Institute of Standards and Technology (NIST) to investigate and determine the most likely technical cause of these three unprecedented building failures. Sadly, NIST conducted its investigation based on the pre-determined conclusion that all three failures were due to fire — and thus *ignored, dismissed, and denied* the overwhelming and irrefutable evidence contradicting that conclusion.

The Bobby McIlvaine Act — named after 26-year-old Bobby McIlvaine, who was killed by an explosion while entering the lobby of WTC 1 — is draft legislation that would establish a select committee in the U.S. House of Representatives to conduct the unbiased investigation that NIST should have done. Such an impartial investigation, which must include a full inquiry into the possible use of explosives and incendiaries, will enable the American people to finally get to the bottom of this tragic and pivotal event in our nation's history.

You have demonstrated your commitment to transparency, truth, and justice concerning the attacks of September 11<sup>th</sup> by sponsoring House Resolution 14, which called on President Barack Obama to release the 28 classified pages from the Joint Congressional Inquiry. We now urge you to take the next step. We and the great majority of our fellow building and technical professionals will stand by you if you do.
